Official Price at Apple Store Japan

According to the official information from Apple Japan, iPhone 17 is offered in two storage configurations: 256 GB and 512 GB. The prices are:

- iPhone 17 (256 GB): ¥129,800 (tax included)
- iPhone 17 (512 GB): ¥164,800 (tax included)

These prices reflect the standard retail cost at Apple's official sales channels — meaning you get a SIM-free model, directly from Apple, with full warranty and support.

What You Get for the Price

Buying iPhone 17 at the official Apple Store in Japan means getting the standard global model that includes:

- A 6.3-inch LTPO Super Retina XDR OLED display with ProMotion (up to 120 Hz) and high brightness levels.
- A powerful A19 chip delivering high performance and energy efficiency.
- An advanced 48 MP Dual Fusion camera system — suitable for both detailed photos and wide-angle / macro shots.
- Battery life sufficient for all-day use, with improvements over previous generations thanks to both hardware and software optimization.
- Official support for Japanese network standards and full warranty coverage under Apple.

Given this, the listed price corresponds to a high-spec, fully supported device — not a limited or discounted version. For many buyers, that alone is reason enough to prefer the Apple Store over third-party retailers, especially if they value peace of mind and warranty.

How Japan's Price Compares Internationally

Interestingly, Japan remains one of the countries with among the lowest official prices for iPhone 17. In a recent global comparison covering 39 countries and regions, Japan's base price for iPhone 17 was one of the lowest.

This relative affordability contrasts with countries where local taxes, import duties or higher retail margins push the price up significantly. For example, in countries with high import tariffs or different taxation rules, the cost of iPhone 17

— and especially higher-capacity or Pro models — tends to be noticeably higher.

Where Else to Buy — Carriers, Retailers, and Trade-In Options

While the official Apple Store offers the cleanest and most straightforward purchase experience, many buyers in Japan also consider carrier stores (like major local mobile operators) or large electronics retailers. Each has its advantages and trade-offs:

- Carrier stores may offer discounts, installment plans, or bundled offers depending on the contract — but usually lock you into a Japanese carrier.
- Electronics retailers and third-party resellers sometimes list unlocked or “SIM-free” variants — but prices and availability may vary, and warranty or official support could be less straightforward compared to Apple’s own stores.
- Apple’s official trade-in program is also an option: if you bring in a qualifying older iPhone model (e.g. iPhone 12 or newer), you can get a significant credit toward iPhone 17 — reducing the effective cost.

Note: While some non-Apple stores may offer tax-free purchases (especially relevant to tourists), the SIM-free Apple Store version remains a preferred choice for many who want a clean, global device.

When It’s Worth Buying iPhone 17 in Japan

If you are someone who values a globally usable phone — no carrier lock, no extra bloatware, official warranty, and easy resale — buying iPhone 17 directly from the Apple Store in Japan is a solid option. Especially given that the official retail price is comparatively low worldwide, you might end up paying less than in many other markets.

For travelers or people relocating internationally, the Japanese Apple Store version often makes sense. The SIM-free model allows you to use your home carrier (or eSIM) without being tied to Japanese carriers, and you get Apple’s standard warranty and support. What You Should Check Before Buying

- Consider exchange rate fluctuations and any import/tax rules if you are traveling internationally or exporting the phone. Price advantages may vary depending on conversion rates.
