- iPhone 17 (512 GB) — ¥164,800

Apple’s global warranty policies and differences in mobile networks can affect your experience.
- **Currency exchange and timing:** Because yen-to-your-home-currency exchange rate fluctuates, the real cost advantage may vary. Consider exchange rate and possible conversion fees when comparing with prices at home.
